### Defining Armed Conflict in International Humanitarian Law

April 30th, 2020 - International Humanitarian Law based on the concepts of jus ad bello is defined to be the law of war This means that the laws involved are meant to be active in a situation of an armed conflict or during war However just like international"Law of Armed Conflict Globalization101
